Subject: Extension of the Period of Accreditation status granted to UG Information Technology programme of PSG College of Technology, Avinashi Road, Peelamedu, Coimbatore- 641 049, Tamil Nadu by one year.

Sir,

This has reference to NBA's letter of even number dated 18-12-2014 under which UG Information Technology program offered by your Institution was granted accreditation for 5 years in Tier-I by National Board of Accreditation..

2. National Board of Accreditation has decided that in all cases where UG Engineering programs of an Institution were granted accreditation for a period of 5 years in Tier-I/II format and if they do not meet all the parameters of pre-qualifiers for extension of duration of accreditation from 5 years to 6 years, the period of accreditation of these program(s) shall be extended by one year subject to the condition that they meet all the parameters of the Pre-visit qualifiers for accreditation of 3 years. The Pre-visit qualifiers submitted by **PSG College of Technology, Avinashi Road, Peelamedu, Coimbatore- 641 049, Tamil Nadu** in respect of the UG Information Technology program have been considered. The programme is meeting all the parameters of pre-visit qualifiers for accreditation of 3 years. Accordingly, the competent authority in NBA has approved the following accreditation status to the program as given in the Table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The program has been granted extension of duration of accreditation for one year. **PSG College of Technology, Avinashi Road, Peelamedu, Coimbatore- 641 049, Tamil Nadu** is requested to apply afresh for accreditation of the program at least five months before the expiry of validity of accreditation.



The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **PSG College of Technology, Avinashi Road, Peelamedu, Coimbatore- 641 049, Tamil Nadu** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

6. The accreditation status of the above program is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited program as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.

7. The accreditation status awarded to the program as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
