Sir,

This has reference to NBA's letter of even number dated 01-02-2018 under which the Masters in Business Administration program offered by your Institution was granted provisional accreditation for 2 years upto 30/06/2019 by National Board of Accreditation.

2. National Board of Accreditation (NBA) has decided that in all cases where Management program(s) of an Institution were granted provisional accreditation for a period of 2 years, the period of provisional accreditation of the program(s) shall be extended from 2 to 3 years subject to the condition that they meet the Pre-visit qualifiers. The Pre-qualifiers submitted by PSG College of Technology, Avinashi Road, Peelamedu, Coimbatore- 641 049, Tamil Nadu in respect of Masters in Business Administration program have been considered in NBA. The Masters in Business Administration program meets all the parameters of Pre-visit qualifiers. Accordingly, the competent authority in NBA has approved the following accreditation status to the program as given in the Table below:

As such the Institution should nowhere along with its name, including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation.
