This has reference to NBA's letter of even number dated 04-01-2024 under which Master of Computer Applications program offered by your Institution was granted accreditation for 2 years from the Academic Years 2022-23 to 2023-24 i.e., upto 30-06-2024 under Tier I January 2013 document by National Board of Accreditation.

2. National Board of Accreditation (NBA) has decided that in all cases where MCA Program of an Institution was granted accreditation for a period of 2 years, the period of accreditation of the program shall be extended from 2 to 3 years subject to the condition that the program meets the essential parameters of the Pre-Qualifiers. The Pre-qualifiers submitted by **PSG College of Technology, Avinash Road, Peelamedu, Coimbatore- 641 004, Tamil Nadu** have been considered in NBA. The MCA program meets all the parameters of pre-qualifiers. Accordingly, the Competent Authority in NBA has approved the following accreditation status to the program as given in the Table below:
